SUBJECT: INSTRUCTIONS REGARDING DOCUMENT VERIFICATION, SEAT ALLOCATION, AND FEE STRUCTURE

All provisionally selected students for cap round -III are hereby requested to take note of the following important guidelines regarding document verification and final confirmation of admission:

1. Mandatory Document Verification & CGPA Conversion Certificate

All provisionally selected students must present an official CGPA-to-Percentage Conversion Certificate issued by their respective institute or university during document verification. This certificate, along with all other required original documents, is mandatory to secure the final confirmation of admission.

2. Information for CIWGC Students Allocated seats against PIO/OCI/FN vacant seats

- **Seat Acceptance and Category Allocation:** Students who have been allocated a seat against the PIO/ OCI/ FN quota in this round will have their admission secured strictly under the PIO/ OCI/ FN Category.
- **Fee Structure Applicability:** Students accepting seats under the PIO/ OCI/ FN category must pay the tuition and applicable fees as prescribed for the PIO/ OCI/ FN Category.
- **Fee Differential:** Please note that the PIO/ OCI/ FN category fee is 5 times higher than the standard normal category fee.
